Reinsurance Calculations

EDGE Server First RI Calculation – 1/12/2015

CMS will be releasing the remote command to run the first reinsurance calculation on issuers' EDGE servers around 4:00p.m. Eastern Standard Time (EST) today.

In order to ensure that this estimate run occurs on each issuer's EDGE server, issuers should upgrade their server to the latest EDGE Version. Next, issuers should execute the EDGE version command "/opt/edge/bin/edge version" to initiate the execution of the calculation job. If an issuer has configured the cron job on their EDGE server ("On-Premise EDGE Server Provisioning" Section 4.5), the remote command for the calculation will be executed automatically.

On January 6, 2015, CMS requested that all issuers submit a new enrollment file to their servers so that issuers' enrollment records could be run through an updated version of the EDGE server software. Issuers that have not yet submitted a new enrollment file may encounter errors in the calculation. Additionally, there is a known defect in the RI calculation that is incorrectly including some small group plan enrollees in the reinsurance calculation. Issuers should disregard any reinsurance payment amount in their detailed reinsurance reports for small group enrollees.

Issuers are expected to complete the RI calculation by January 16, 2015. If for some reason you are unable to complete this process, please follow-up with your Account Manager as quickly possible. The remote command for the next round of risk adjustment estimates are expected to release on January 16, 2015.
